- Present the final production work to DGTrials for review, in advance of release by a minimum of 48 hours, to demonstrate that the aforementioned criteria are met. If the submitted item does not meet DGTrials standards, the signer is obligated to correct the problem(s) as designated by DGTrials prior to release.

In the case that the signer will take photography for distribution online (via the internet) or distribution via hard copy (newspaper, magazine, etc), the signer agrees to:

- Display the DGTrials logo prominently in any article or printed publication.

- Include information about the event and location of the event in any article or printed publication.
- Include the DGTrials URL and logo as an overlay to all photos hosted online, if possible.
- Present any final production work to DGTrials for review that the aforementioned criteria are met.
